

# LONG-TERM RESIDENCY IN HUNGARY means the freedom of movement and stay within the Schengen Agreement countries

Whether for personal growth, career opportunities, or the love of travel, long-term residency in Hungary unlocks endless possibilities across the continent. Start your European journey today!



Since there's no obligation to live in Hungary, individuals with this status are free to live anywhere globally, maintaining their privilege of limitless visa-free access and travel within the Schengen Area.



The status of a long-term resident in Hungary also grants you unrestricted access to both Hungarian and European financial systems without any limitations.



Having the status of a long-term resident in Hungary does not automatically make you tax liable in Hungary, but it does give you the option to become a tax resident of the country if you live in Hungary for more than 183 days a year, or by choice after filing the appropriate application.

Holders of Hungarian residency obtained by investment are entitled to a full range of state guarantees and social rights, including the right to work and conduct business activities.



The conditions for participation in the long-term residency program in Hungary by investment are regulated by Act XC of 2023 on the General Rules for the Entry and Residence of Third-Country Nationals, abbreviated in Hungarian as: "Btátv"

#### **FUND**

This option involves purchasing an investment fund share worth at least EUR 250,000, issued by a real estate fund registered with the Hungarian National Bank.



## **PROPERTY**

This option allows the acquisition of ownership of a residential property in Hungary, valued at a minimum of EUR 500,000, registered in the Land Registry under its parcel identification number and free of liens, claims, and encumbrances. This option will be available starting January 1, 2025.




## **DONATION**
